## Mitsubishi Electric Announces Status of Company Stock Repurchase

According to Articles of Incorporation Pursuant to Article 459, Paragraph 1 of Companies Act of Japan

**TOKYO, September 4, 2024** – <u>Mitsubishi Electric Corporation</u> (TOKYO: 6503) announced today the status of its repurchase of company stock pursuant to the provisions of Article 459, paragraph 1 of the Companies Act, as well as Article 31 of the company's articles of incorporation approved by the Board of Directors on August 29, 2024, as shown below.
